In FY25, the affiliate sold 2 homes to local families, re-located a ReStore location, and have an additional 7 properties under some phase of construction. All homes under construction are completely funded. Attended by our friends in local community housing organizations, along with our community finance partners, we hosted a first-time Homeowner Readiness Resource Fair open to all renters in eastern CT and drew over 50 households. The first and second groups of new homeowner partners were voted into the re-designed homeownership program, so we're now partnering with 6-8 families at a time (our ultimate goal for # homes sold/year is 8-10)
